Access to the rider showers, parking space and 3 accreditations per horse are included with the stable. BE CAREFUL: stables are in public areas with visitor access, close to the paddock and the Carrière Show, in limited number. Sale of chips (12€) and hay on site (20€).



► **SHOW BBR OPEN 4 DIVISIONS:**

The closing date for commitments is 25th November 2019, as evidenced by the postmark. No refunds will be made after this date.

The races of the Barrel Race Competition are held under electronic chronometer to the thousandth.

The Paris Barrel Race Competition is a two-point competition. There are 4 divisions at 0.5 seconds. The best time of the round determines the first division.

The Run on Saturday 04 December and the Run on Sunday 08 December 2019 are separate. At the end of each run, a prize-giving ceremony will take place. If at the end of the first run more than 10 riders per division are qualified, only the first 4 will be awarded. If there are less than 10 riders per division, the distribution of prices will be based on the number of qualified riders:

- **From 1 to 3 riders:** the three riders are awarded prizes
- **From 4 to 10 riders :** only the first four riders who won the run will be awarded prizes

Below is the Payback percentage table.

All BBR and non-member riders can participate in the competition. The riders run under the same rules

BBR price discount: 1500€ per run + 75% of the pay back commitments (35 euros) are repaid.

The best rider who has participated in both legs and who at the end of the Paris Barrel Race Competition will have sufficient qualifications will be offered a round trip air ticket to participate in the BBR Open World Championship in Oklahoma city. The booking of the flight ticket must be made by the organizer up to a maximum of 500€.

To qualify for the BBR Oklahoma Open Final, you must have completed 4 gold card races and 6 single membership races before the Paris Barrel Race Competition.

The best rider on both heats is the one with the lowest common denominator in terms of number of points.

In case of a tie between riders, a draw by a contest judge will be made to determine the winner.

► **BARREL LAYOUT**

The first and second barrels are placed at 6 m from the edge, the third barrel at 7 m. The stopwatches are placed 11 m from the first barrels.

The use of whip and reindeer waves is allowed. The track judge reserves the right to eliminate a rider in case of abuse.

► **ELIMINATION CASES**

Fall of a barrel - fall of the rider - Error of course - and any action that could affect the integrity of the animal.

► **CANCELLATION OF THE COMPETITION**

If less than 10 riders are registered for each run of the Paris Barrel Race Competition, the organizer has the right to cancel the competition and will not refund any money.

► **SAFETY AND INSURANCE**

The participants in the Competition undertake to respect the security conditions of the Show.

Due to the presence of animals, they will ensure compliance with the relevant health and safety rules.

They declare that they have taken out, with a company known to be solvent, all the necessary insurance covering their equipment, horses and civil liability for any material and immaterial damage resulting of their participation in the Paris Barrel Race Competition.

Participants shall provide at COMEXPOSIUM's first request, with the corresponding certificates of their insurer, which are valid, indicating the cover taken out, their amount and their period of validity.

► **STABLE REGULATIONS**

These General Conditions apply to any stable reservation by a user (hereinafter the "Client") from this form and are intended to define the conditions for stable reservations in Hall 5A, located in a zone accessible to the public, during the Paris 2019 horse show, held from 04 december 2019 to 08 December 2019 (hereinafter the "Show"), organised by COMEXPOSIUM - 70 avenue du Général de Gaulle 92058 Paris La Défense - RCS Nanterre 316 780 519 (hereinafter the "Company").

These general conditions may be modified at any time at the Company's initiative. Any modification of these general terms and conditions as well as the documents to which they refer will be communicated to the Client when he first uses the Site after this modification.

► **ORDER DETAILS**

Prior to any stable reservation, the Client expressly acknowledges having read these general conditions, the details given on the reservation form

The reserved stables are payable upon order, this contract being formed upon receipt of full payment of the boxes.

All orders, regardless of their origin, are payable in euros. Payment must be made by cheque made payable to Showtime Organisation, which must be attached to the booking form.

► **PERSONAL DATA**

Information and personal data concerning the Customer are necessary for the management of his order and his commercial relations with the Company. This information and data are also kept for the duration of the commercial relationship with the Client and for security purposes, in order to comply with legal and regulatory obligations, as well as to enable the Company to



improve and personalize the services offered and the information it receives.

Only the Company's internal teams and the service providers it has authorized have access to personal data concerning the Client.

#### ► PROVISION OF ACCESS TICKETS

##### - PRINTING OF ACCESS TICKETS (E-Tickets)

Each Access Pass is STRICTLY personal (an identity check of the holder may be carried out at the entrance to the Fair) and non-transferable.

To be valid, the Access Card must be printed in portrait mode (vertical) on a white, blank A4 sheet of paper on both sides, without changing the print size.

It is specified that no other support (electronic, PC screen, laptop screen...) is accepted

Access Titles must have a good printing quality. Access Titles that are partially printed, soiled, damaged or illegible will not be accepted and will therefore be considered invalid. In the event of poor print quality, it is the Customer's responsibility to reprint his Access Card.

Access Tickets are provided with a unique barcode allowing one person to access the Show during the validity period of the Access Ticket. The validity of Access Tickets is checked at the entrance to the Fair using barcode readers.

It is prohibited to reproduce, duplicate or forge the Access Certificate in any way.

Consequently, the Company may refuse entry when several prints, reproductions, copies or imitations of the same Printable Home Access Permit are in circulation and access to the Fair has already been granted in advance to the holder of a print, reproduction, copy or imitation of the corresponding Access Permit.

The Company declines all responsibility for any anomalies that may occur during ordering, processing or

In the event of loss, theft or unlawful use of the Access Card, no duplicate or certificate of any kind whatsoever, other than the

only Access Card that can be printed by the Customer, will be given to the Customer.

#### ► CANCELLATION - ORDER MODIFICATION - REFUND - USE

All orders are firm and definitive and irrevocably commit the Client to full payment of the price. Consequently, no refund will be made for any reason whatsoever, and in particular in the event of partial or total cancellation of the order.

Similarly, the Company will not make any changes to the Access Securities ordered (name of the holder, position, company, etc.).

In this respect, the Customer is invited to carefully check the data provided before validating his order.

The sale of Access Tickets on the public domain, in a private place or on the Internet, is a criminal offence punishable by arrest and arrest by the police forces, punishable by a fine of €15,000 (art. 313-6-2 of the Criminal Code).

Upon announcement of the cancellation or modification of the date or time of the Fair for which the Client has ordered one or more Access Tickets, the Client agrees that the Company may use the contact details entered by the latter when ordering online to inform him of the procedure to be followed.

In the event of cancellation of the Fair by the Company due to force majeure, within the meaning of French case law, the Company will notify the Customers without delay. In such a case, there will be no damages and the sums received by the Company will be returned to the Client.

#### REMINDER OF THE MAIN SAFETY RULES

On quarries and recreational paddocks, the wearing of a bomb attaches three points, bomb or helmet is mandatory (CF Regulation FFE). Outside the quarries and relaxation paddocks, riders must be on foot, hold their horses in hand and move around taking all the usual precautions.

All participants undertake to ensure that their personal insurance (civil liability, personal accident, etc...) is valid. In this respect, the Client declares that he is duly insured for any damage/damage that may occur due to the horses present at the Show. The competitors' horses and equipment remain under their care and responsibility throughout the duration of the Show

For reasons of safety and animal health protection, we remind you that it is strictly forbidden to smoke inside the Salon du Cheval de Paris under penalty of a fine and exclusion from the Salon.

#### ► HEALTH AND IDENTIFICATION CONDITIONS:

##### IDENTIFICATION

Equidae must be provided with their duly completed official identification document and a transponder (electronic chip) in accordance with the national regulations in force

## VACCINATION

Horses resident in France: Equidae must be up to date with their vaccinations against equine influenza.

Horses from a Member State of the European Union: Equidae must have an official health certificate for intra-Community trade.

Horses from a third country: Equidae must have a border crossing certificate. For any questions regarding the importation of equidae into the national territory, please contact the Border Inspection Post at the following address: pif93.sivep@agriculture.gouv.fr

## TRANSPORTATION

For amateurs who transport their own horse, a check of the owner's card can be carried out at the health checkpoint.

For professionals, the following rules apply:

For all journeys over 65 km of short duration (less than 8h00), it is necessary to be able to provide:

### - A Type 1 authorization

A certificate of professional competence for the transport of live animals (CAPTAV)

For all journeys longer than 65 km (more than 8 hours), it is necessary to be able to provide:

### - A Type 2 authorization

A certificate of professional competence for the transport of live animals (CAPTAV)

An approval of the vehicle for long term travel.

For any questions relating to the legislation in force, please contact the Departmental Directorate of Population Protection or the Departmental Directorate of Social Cohesion Populations of your department.

## DISINFECTION OF VANS / TRUCKS

A complete disinfection of vans and trucks is mandatory for all stays at the show. A disinfection service will be provided upon arrival at the exhibition grounds.

## DOG PRESENCE

Competitors' and exhibitors' dogs are tolerated within the Exhibition grounds with the exception of category 1 and 2 dogs prohibited on the Exhibition. In any case, dogs are not allowed in areas accessible to the public during the opening hours of the Show and must remain attached under all circumstances and this, under penalty of exclusion from the Show. The dogs remain in the custody and responsibility of the Client throughout the duration of the Show.

In this respect, the Client declares that he is duly insured for any damage/damage that may occur as a result of his dog(s) during their presence at the Show

They must undergo a health check before entering the Salon and meet the following conditions:

Dogs residing in France: Dogs must be identified (tattoo and microchip) and in good health.

Dogs from a Member State of the European Union: Dogs must be identified (tattoo and microchip), vaccinated against rabies and equipped with their European passport

Third-country dogs: Dogs must be identified (tattoo and microchip), vaccinated against rabies, serum anti-rabies antibody titration and have a health certificate

## ► REGLEMENT OF DISPUTES
